I, Dr. S. K. Jain, Practicing Company Secretary of Mumbai has been appointed as the Scrutinizer by the Board of Directors of **DCW LIMITED** at its Meeting held on 28th June, 2019 as the Scrutinizer for conducting Postal Ballot / e-Voting process and I have given my consent to act as Scrutinizer vide letter dated 27th June, 2019 for passing of the following Special Resolutions by Postal Ballot:

I hereby submit my Report as under:-

- a. The Company completed the dispatch of the Postal Ballot Notice along with the Postal Ballot Forms to all the Shareholders through courier and also sent the said documents through e-mail to the Shareholders whose e-mail ids are registered with the Company. The said process was completed by 5th July, 2019.
- b. The Company had made an advertisement regarding dispatch of Postal Ballot Forms/Notices in Financial Express (English Newspaper) and in Financial Express (Gujarati Newspaper) on Thursday, 18th July, 2019.



- c. The Company has availed the services of NSDL [National Securities Depository Services (India) Limited] to provide e-Voting facilities to the Members of the Company.
- d. The remote e-Voting commenced from 9:00 a.m. (IST) on Friday, 26th July, 2019 and ended at 5:00 p.m. (IST) on Sunday, 28th July, 2019.
- e. I have monitored the process of electronic voting through the Scrutinizer's secured link provided by NSDL on the designated website www.evoting.nsdl.com
- f. There were 58,211 Members of the Company as on 21st June, 2019. Out of the said 58,211 Members, 37,948 Members had registered their e-mail ids with M/s. Bigshare Services Private Limited (R&T) and accordingly Postal Ballot Forms were sent to the said Members through e-mail on 4th July, 2019. To the 20263 Members, the Postal Ballot Notices along with Postal Ballot Forms were sent through Courier and dispatch was completed on 5th July, 2019. Out of the 37,948 e-mails sent to Members, 6617 bounced back which were sent through Courier on 9th July, 2019.
- g. All Postal Ballot Forms received and e-Votes casted up to 5:00 p.m. on Sunday, 28th July, 2019 the last date and time fixed by the Company for receipt of the votes/forms were considered for my Scrutiny.
- h. The Postal Ballot Forms received during the voting period were kept under my safe custody and were opened in my presence. The e-Voting module was unblocked at 5:15p.m. on 29th July, 2019 in the presence of two witnesses, Ms. Vrushali Shirdhankar and Ms. Nivyata Batavia, who are not in the employment of DCW Limited. They have signed below in confirmation of the votes being unblocked in their presence and the e-Voting results/list was downloaded from the NSDL website.

- I received total 79 Ballot Forms from the Members of the Company. Out of the 79 Ballot Forms, 10 Forms were found invalid.

- n. I have handed over the Postal Ballot Forms and other related papers/registers and records for safe custody to the Company Secretary of the Company.
